**1.0 Review Previous Minutes**

Ms. Somers moved to approve the minutes from last meeting, Ms. Thorpe seconded the approval. Mr. Adams went over the minutes and hit upon how to give the information for the 6 day schedule. Ms. Somers shared what she used for giving the information to parents. Team voted for that form to be sent to all teachers. Ms. Somers will send form to Mr. Adams and teachers will send that cover letter and the calendar home. **3.0 School Budget Amendments and Adjustments**

Mr. Adams discussed the budget shortfall and how that affects every school differently. He reviewed the budget and shared that we have a \$6,593.36 shortfall. Still have the \$14,000 or so from the extra position for the morning technology slot that hasn't been filled. Ms. Bratsouleas said that speaking for the specialists they are fine with still covering. Mr. Adams said that the other specialists are also ok with still covering. Consensus (5/5) that the \$14,950 will be taken off the budget. Now a surplus of \$8,356.64. Ms. Bratsouleas asked the amount for Ron Clark. Mr. Adams stated \$1,300/person for Ron Clark, about 20 who could still go. That would be 7 people to go in the spring. Mr. Adams stated we can put it into the general supply budget to do what we please with. Ms. Thorpe asked about Ms. Allen doing after/before tutoring out of the surplus money. It would be enough for 120 days and 3 hours a day. Ms. Bratsouleas stated that teachers should

have the choice/opportunity prior to offering it to another person. Team voted and came to consensus (5/5) to have the \$8356.36 into general budget.

Ms. Rodriguez talked about Ms. Yvonne and the backpack vacuum being so heavy. Mr. Adams said that she had come to him too. Mr. Adams will work on getting it ordered within the week.

#### **4.0 Good of the Order**

Mr. Adams shared that within the state of Nevada there is 104 Zoom schools. We are number 3 in the whole state. The proficiency levels are not where we want them to be, but the gains when comparing from grade level to grade level is where we are beyond the state and the district.

Ms. Bratsouleas shared that she enjoyed being on the team.

Ms. Thorpe also said that it was a pleasure being on the team and will be reading the minutes and coming for public comment if needed.
